#### 1. CONTEST PERIOD

All Squamish Seniors Centre Society NEW members that have paid their \$10.00 membership fee for 2023 between October 27, 2022, and December 17, 2022 at Five (5) PM Pacific Standard Time will be eligible.

Elected 2023 members and previous members of the Board of Directors of the Squamish Seniors Centre Society and immediate family members and/or those living in the same household are not eligible to participate in the contest.

#### 3. METHODS OF ENTRY
